

# 2024/2025 Chinese Government Scholarship (MUC)

## 1. Program Categories, Duration and Language of Instruction

- (1) This scholarship supports graduate students.
- (2) The study duration is 2-3 years for Master's students, 4 year for Doctoral students.
- (3) Students in Minzu University of China are instructed in Chinese or English.

## 2. Application Receiving Agency and Deadline

**Applicants should apply to Minzu University of China before (date) February 18, 2024.**

## 3. Eligibility

To be eligible, applicants must:

- ▶ be a citizen of a country other than the People's Republic of China, and be in good health;
- ▶ be a bachelor's degree holder under the age of 35 when applying for master's programs;
- ▶ be a master's degree holder under the age of 40 when applying for doctoral programs.

## 5. Application Procedure and Documents

### ▶ Application Procedure

- (1) Applicants directly apply to the designated Chinese universities undertaking this program.
- (2) Recommended candidates must finish the online application procedure at CSC Online Application System and Minzu University of China (MUC) Online Application System for International Students. Please go to <https://studyinchina.csc.edu.cn/#/login> and <http://lxs.muc.edu.cn/member/login.do> and click Application Online for International Students, complete the required information, submit the completed Application Form and related materials.
- (3) Applicants should consult the designated Chinese universities for the instructions of the CSC Online Application System for International Students and Agency Number.

### ▶ Application Documents

- (1) Application Form for Chinese Government Scholarship (in Chinese or English) .
- (2) Notarized highest diploma: Prospective diploma winners must submit official proof of student status by their current school. Documents in languages other than Chinese or English must be attached with notarized Chinese or English translations.
- (3) Academic transcripts (from the undergraduate program onwards): Copies of academic records from first to last semester during the undergraduate, graduate (if any), and doctoral programs (if any) shall be provided. These transcripts shall be issued and sealed by the attending university's academic affairs office, graduate school, or student management department. They can be in Chinese or English, but must be attached with notarized English translations if they are in foreign languages other than English;
- (4) A Study Plan or Research Proposal in Chinese or English: Doctoral students should write at least 1500 words, Master's students should write at least 1000 words. the proposal of a doctoral student shall be signed by the applicant's Chinese supervisor
- (5) Two letters of recommendation in Chinese or English from professors for Doctoral students. Two letters of recommendation in Chinese or English from professors or associate professors for Master's students. These letters shall describe the applicant's objectives of learning in China, comprehensive abilities, and evaluation of future growth, as well as the cooperation between the supervisors or the exchange between universities both in China and abroad;
- (6) Language qualification certificates: Applicants should have acquired the Chinese proficiency of HSK Level 4 when applying for Chinese taught master's or doctoral programs at least; Applicants for English taught programs shall provide IELTS or TOFEL report.
- (7) Foreigner Physical Examination Form, please written in English. The physical examinations must cover all of the items listed in the Foreigner Physical Examination Form. Incomplete forms or forms without the signature of the attending physician, or the official stamp of the hospital, or a sealed photograph of the applicant are considered as invalid. Please carefully plan your physical examination schedule as the result is valid for only 6 months.
- (8) Copy of First Page of Passport: If the validity of the applicant's current passport does not meet the requirement (meaning the passport expires before September 2024), please apply for a new passport before submitting the application.
- (9) Non-Criminal Record Report: The applicant shall submit a valid certificate of Non-Criminal Record issued by the local public security authority, usually issued within 6 months prior to the submission date of the application.
- (10) Example of art: To apply for majors related to art or design, applicants could submit their own works through "Example of Art/Other Supporting Documents" in the system. Applicants could also provide such materials to the applied universities.

(11) Supervisor Acceptance Letter (If any): Information of the applicant's Chinese supervisor;  
Descriptions of the applicant's studies or research in China.
